**Colombo South Sand Nourishment Project – Stabilization of Mt. Lavinia to Angulana Coastal Stretch Using Sand Engine Method and Restoration of Eroded Natural Sand Bar at Kalutara River Mouth  
(Contract No. CCD/RD/08/32/SN/MLAN)**

- 1.0 The Democratic Socialist Republic of Sri Lanka has initiated Colombo South Sand Nourishment Project – Stabilization of Mt. Lavinia to Angulana Coastal Stretch Using Sand Engine Method and Restoration of Eroded Natural Sand Bar at Kalutara River Mouth of Sri Lanka, with fund allocations from Government of Sri Lanka (GOSL), and intends to procure services for mining of sea sand from the intended off-shore borrow area and nourishment at Mount Lavinia to Angulana coastal stretch by Sand Engine Methodology (Proposed Stretch 1) and Re-creation of natural sand bar at Kalutara River Mouth (Proposed Stretch 2).
- 2.0 The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC) on behalf of the Ministry of Mahaweli Development & Environment, now invites sealed bids from eligible & qualified dredging contractors for mining of **Eight hundred thousand cubic meters (800,000 m<sup>3</sup>)** of sea sand from off-shore borrow area extended 6 km<sup>2</sup> from midpoint of 6°48'2.13"N, 79°49'43.62"E and nourishment locations which describes as bellow.

(Note: These locations may vary approximately 500m northward or southward according to the site conditions at the time of beach nourishment.)

The bidders with required experience in off-shore sand mining and beach nourishment projects and vessels with necessary plants and equipment for off-shore sand mining in depth beyond 15m pumping & spreading on-shore shall submit the bids. The contract is expected to be completed within **three (03) months** from the date of Commencement as in the Letter of Acceptance.

- 3.0 Bidding will be conducted through International Competitive Bidding (ICB) procedure.

- 5.0 Qualification requirements include ability to employ major equipment (dredger, supporting vessels, floating or sinker pipe lines, heavy on-shore machineries etc.) of required capacity and experienced personal to complete the work within the intended time period. Additional details are provided in the bidding documents.
- 6.0 A complete set of Bid Documents in English language may be purchased by interested bidders from **2019.08.01 to 2019.09.11 Between 09.30 hrs and 15.00 hrs**, on submission of a written request to the address above, and upon payment of a non-refundable fee of Sri Lanka Rupees Eighty Thousand (LKR 80,000/=). The method of payment will be by cash. The Bid document is not transferable.
- 7.0 Bids must be delivered to the Additional Secretary (Technical) of Ministry of Mahaweli Development & Environment at the address below on or before **14.00 hrs on 2019.09.12**. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who are willing to attend, immediately after the closing of the bids. All bids must be accompanied by a Bid Security of LKR 8,000,000.00 (Eight million).
