



PROCUREMENT NOTICE

SUPPLY OF EMPTY LPG CYLINDERS (37.5kg)

CONTRACT PERIOD: 2026 & 2027

The Chairman, Ministry Procurement Committee (MPC), on behalf of Litro Gas Lanka Limited, invites sealed bids from eligible and qualified bidders for the supply of Empty LPG Cylinders (37.5kg) without valves for the 2026-2027 biennial period.

To be eligible for contract award, bidders must not have been blacklisted or debarred, locally or internationally, by any government institution, regulatory authority, or recognized commercial entity. Bidders shall have no conflict of interest in the business of Litro Gas Lanka Limited or its associated companies, as defined in the Procurement Documents.

Bids must be submitted by reputable manufacturers holding a valid permit from the Sri Lanka Standards Institution (SLSI) for the manufacture and supply of LPG cylinders under the SLSI mark. This certification must be valid at the time of the bid closing date.

All bids must be accompanied by an irrevocable, unconditionally encashable Bid Security in the form of a bank guarantee. This guarantee must be issued by a licensed commercial bank operating in Sri Lanka. For guarantees issued by foreign banks, the instrument must be confirmed and assured by a licensed commercial bank operating in Sri Lanka, issued in favor of Litro Gas Lanka Limited.

The cylinder quantities and the value of the bid security and validity period of the bid security is as follows:

In accordance with the Public Contracts Act No. 3 of 1987, it is mandatory for all bidders to be registered with the Registrar of Company. A valid PCA Certificate must be submitted prior to the award of the contract.

A Pre- bid meeting will be held on **3rd September 2026**. The bidders are required to register for the Pre – bid meeting by submitting their details to the email address **Damith.liyanage@litrogas.com**, Litro Gas Lanka Limited.

Procurement documents will be issued to eligible bidders upon payment of a non-refundable fee of USD 180.00 (via bank transfer) or LKR 60,000.00 (via pay order from a registered commercial bank in Sri Lanka). Documents are available for collection on working days between 9:30 a.m. and 3:00 p.m. from 10th August 2026 to 22nd September 2026.

The duly completed Bid Documents should be deposited in the Tender Box placed at the 05th Floor of the Litro Gas Lanka Limited Head Office, No 267, Union Place, Colombo 02, Sri Lanka on or before **3:00 p.m. on 23rd September 2026**. Opening of bids will be conducted soon after the bid closing at the 4th Floor auditorium of the above premises. **Late bids will be rejected.**
